

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.clickmedias.com, and CLICK MEDIAS, INC. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to CLICK MEDIAS, INC. include www.clickmedias.com and Click Medias, Inc.. Collection of your Personal Information

In order to better provide you with products and services offered, Click Medias, Inc. may collect personally identifiable information, such as your:

- First and Last Name
